#### 1. ABOUT THE TERMS

##### DEFINITIONS.

As used in these Terms of Use:

## 2. ABOUT THE WEBSITE

### LICENSE TO USE

Subject to your compliance with the Terms, WE RENT A CAR grants you a limited non-exclusive, non-transferable, non-assignable and non-sublicensable license to access and use the Website, including the right to download. This license is granted for the sole purpose of enabling you to use and enjoy the benefit of the Website as provided by WE RENT A CAR, in the manner permitted by the Terms.

### MODIFICATIONS AND UPDATES TO THE WEBSITE

WE RENT A CAR reserves the right, in its sole discretion, to modify or discontinue offering the Website in whole or in part, or any features, functionality, tools or content thereof, at any time, for any reason or no reason, with or without notice to you. We may from time to time develop and provide updates for the website, which may include upgrades, bug fixes, patches and other error corrections and/or new features, functionality, tools or content (collectively, “**Updates**”). ### INTERNATIONAL USERS.

The Website is controlled and operated within the kingdom of Bahrain. ### ACCOUNT REGISTRATION

## PAYMENT/ CREDIT CARDS

YOU ARE RESPONSIBLE FOR PROVIDING WE RENT A CAR WITH VALID CREDIT CARD OR PAYMENT ACCOUNT DETAILS AND FOR THE TIMELY PAYMENT OF ALL FEES. Please note that the payment information, including name and contact information, that you submit when you register may be used and shared with our payment processing services provider and otherwise used in accordance with our Privacy Notice.

## 5. USER CONDUCT GUIDELINES

You agree that you will access and use the Website for your personal use only. Any time you access or use the Website, you are required to comply with our User conduct guidelines, as set forth below.

You are not authorized to access or use the Website:
